Abstract:

Restore 72 acres of critical habitat along the Mississippi River, including restoration and enhancement of prairie, oak savanna, oak forest and shrub swamp, to improve waterfowl and upland game bird feeding and nesting habitats.

Design and Scope of Work:

Nestled along the Mississippi River, the Ramsey County bluff lands consist of interlinking prairie, oak savanna, oak forests and shrub swamp seep wetlands. This eclectic mix of habitats provides shelter and food for upland game birds, nesting birds, waterfowl, and white-tailed deer. Overtime the bluff lands have become highly degraded by adjacent development and invasive species, providing less of a sanctuary for the animals and birds that inhabit this area. Past surveys of this area have shown that invasive species are overtaking high quality native vegetation at an alarming rate and encroaching even further more into the sensitive areas, such as the unique bluff land swamp shrub wetland seeps.

Pursuant to the Ramsey County Parks and Recreation Natural Resources Management Plan to "restore degraded habitats to function as quality habitats for diverse native wildlife communities and water resource protection" and the Tomorrow's Habitat for the Wild and Rare action plan "to manage Minnesota's populations of species in

greatest conservation need," the goal of this project is to restore 72 acres of critical bluff land habitat along the Mississippi River within Ramsey County. The restoration will include 5 acres of prairie and enhancement of 51 acres of prairie/oak savanna, 6 acres of shrub swamp wetlands and 10 acres of forest. The focus will be to improve wildlife habitat by eradicating invasive vegetation through cutting and controlled burns, replanting and seeding of native vegetation, and protection of mature forest trees while restoring the natural forest understory. The prairie and oak savanna will be restored to enhance native vegetation growth of grasses and forbs, such as little and big bluestem, porcupine grass, Pennsylvania sedge, blazing star, bush clover, hare bells, blue aster, and the State listed species kittentails, all to promote upland game and nesting bird habitat. The shrub swamp wetland seeps will be enhanced to improve a mixture of vegetation consisting of speckled alder, sedges, with scattered pockets of marsh marigolds and skunk cabbage, to advance feeding and nesting sites for snipe, woodcock and migratory waterfowl broods traveling along the Mississippi Flyway. The oak savanna and woodland areas will be enhanced to protect mature bur, northern pin and white oaks and revive the understory for new generation of oak trees that will provide shelter for upland game species like white-tailed deer. Once completed this restoration project will also expand quality wildlife corridor lands by connecting other surrounding past restoration projects, consisting of a restoration project to the northwest completed in Indian Mounds Park and a restoration project to the south within Battle Creek Regional Park, which is also located in the popular Ramsey County Parks and Recreation white-tailed deer management archery hunt zone. These previous restoration sites were funded with grants provided by Big Rivers Partnership, Metropolitan Council, National Park Service -Mississippi National River and Recreation Area (NPS - MNRRA) and The State of Minnesota, including funding from the Parks and Trails Fund and the Environmental and Natural Resources Trust Fund.

Ramsey County will utilize in-kind staff hours to manage the project and use only the requested grant funding for on the ground restoration and enhancement of habitat. Ramsey County Parks and Recreation Department, in conjunction with NPS - MNRRA, Friends of the Mississippi River, Great River Greening, Minnesota Conservation Corps, and Ramsey-Washington Metro Watershed District, has a long standing history of successfully restoring and maintaining hundreds of acres of County land for the benefit of wildlife habitat improvement. Ramsey County, along with these partners, will continue this trend through the successful restoration of these bluff lands for wildlife habitat improvement if granted funding.

Relationship to Other Constitutional Funds:

Accelerates or Supplements Current Efforts:

Over the past ten years, Ramsey County Parks and Recreation, along with several other agencies, have organized restoration efforts within the greater bluff lands of Ramsey County, including the restoration and enhancement of over 300 acres within Battle Creek Park. Some of the funding for the restoration of these bluff lands was provided through the Parks and Trail and Environmental Natural Resource Trust Funds. Limited funding has prevented the continuation of these restoration efforts through the proposed site due to the steep terrain, unique wetland features and vast amount of invasive vegetation in this area. If awarded funding the restoration of this 72 acre site will connect with these currently restored areas enhancing the overall wildlife corridor along the Mississippi River bluff lands.

Sustainability and Maintenance:

Ramsey County Parks and Recreation has a long standing history of sustaining restored lands by implementing ongoing maintenance plans to ensure the goals of the project. A maintenance plan will be put in place for the restoration site after the funds are expended. This plan will include surveying the area to monitor the reestablishment of high quality native vegetation and action steps to take when invasive vegetation reemerges. Ramsey County staff will survey the area yearly and the local Minnesota Conservation Corps crew will initially be utilized to continue with the maintenance of the lands.
