#### Members:

The attached letter is from Tom Landwehr, DNR Commissioner, to Chair Hartwell regarding the Vermillion project. The DNR is requesting that the Council combine the recommended appropriation for Vermillion with the recommendation for WMA and SNA acquisition. If this request is agreed to we could write the appropriation language to specify a minimum amount , \$4.250 million, of the available combined funding, \$8.145 million, be directed to the 7-county metro area to maintain the geographic balance of the overall Council recommendations.

There are two reasons to combine the appropriations. The recommendation for the Vermillion acquisition is \$1,750,000 short of the amount required to complete the planned acquisition. If DNR fails to obtain the \$1,750,000 to complete the purchase a standalone Vermillion appropriation could sit unused until the legislature provides more money or the appropriation is cancelled an reappropriated. A combined appropriation makes the funding available for alternative parcels if the planned acquisition isn't possible. Also, each appropriation requires an Accomplishment Plan that needs to be prepared and tracked. It is questionable whether a single parcel acquisition, no matter the price, warrants its own accomplishment plan if there is an ongoing program in which to list the parcel and track the purchase.

## Dear Chair Hartwell:

The Department of Natural Resources has been recommended funding for two wildlife management area (WMA) acquisition proposals: Vermillion River WMA Acquisition proposal (HA-3) with the DNR WMA and Scientific and Natural Area Acquisition proposal (PA1). I'd like to request that these proposals be merged into a single accomplishment plan and recommendation. Combining the proposals will streamline work for the Council and staff, as well as the DNR.
