SUBJECT: MN Laws 2012, Ch. 264 Accomplishment Plan Approvals

### **Background**

MS 97A.056, subd. 12 requires entities receiving Outdoor Heritage Funds to submit accomplishment plans to the Lessard-Sams Outdoor Heritage Council. Those accomplishment plans are the deliverables tied to expenditure of the appropriation. Programs whose accomplishment plans substantially conform to the submitted proposal, draft accomplishment plan, and appropriation language are placed on the consent agenda. Twenty-six of the following MN Laws 2012, Ch. 264, Art. 1, Sec. 2 appropriations are placed on the consent agenda.

Five accomplishment plans are not on the consent agenda and contain substantive changes from the proposal, draft accomplishment plan, and/or appropriation language.
