## **Background**

The Lessard-Sams Outdoor Heritage Council (Council) was established by the Minnesota Legislature and is responsible for providing annual funding recommendations to the legislature on how funds from the Outdoor Heritage Fund should be allocated. The Outdoor Heritage Fund, along with three other funds, was established by the 2008 Clean Water, Land, and Legacy Amendment to the state's Constitution increasing the state sales tax.

As part of the enabling legislation, the Council was required to develop and provide to the Legislative Coordinating Commission "a 25-year framework of funding, consistent with statutory and constitutional requirements." Five years have passed since the creation of the Council and they are interested in a discussion with Council members and staff to review the process used in relation to the Council and sectional priorities and visions outlined in the framework.

Council staff contacted Management Analysis & Development (MAD) of Minnesota Management & Budget to assist the Council in this discussion.

## **Purpose**

MAD would help the Lessard-Sams Outdoor Heritage Council by providing a framework for discussion around the Council's statewide priority actions and section-specific vision and priority actions as outlined in "Appendix C: Planning and managing for results" in the 25-year Framework completed in late 2010.

MAD would interview all Council members and staff regarding their thoughts on the process and if it has produced the expected results (and even whether these identified results are still appropriate). If specific issues are identified in the interviews, MAD may consider and, if needed, develop small group discussions of Council members and interested parties to further understand and/or define the issues.

Based on the information gathered in the interviews and small group gatherings, MAD would, with input from staff and Council leadership, design, facilitate and document, a series of Council workshops to discuss improving the process and how success can be measured through outcomes and expected results.

The time frame would begin July 25, 2013 and continue through January 31, 2014.

#### **Documentation**

Management Analysis & Development would provide the draft copy and the final document in Adobe Acrobat (PDF) format. If requested, the division would provide one paper copy of the draft document and up to four bound paper copies of the final document. Additional bound paper copies of the final document could be provided at a per-document cost.
