### **Suggested Motion:**

Move to approve all of the accomplishment plans for the ML 2016 appropriations as provided in the LSOHC member binders.

Council members may remove plans for further discussion or approval at an upcoming meeting.

## **Background:**

MS 97A.056, Subd. 12 requires recipients of Outdoor Heritage Funds to submit accomplishment plans to the Lessard-Sams Outdoor Heritage Council in the form prescribed by the council for council approval. Those accomplishment plans are the deliverables tied to expenditure of the appropriation. Programs whose accomplishment plans conform to the submitted proposal, draft accomplishment plan (APs), and appropriation language are placed on the consent list.

In order to enable managers to start spending July 1, 2016, the council must approve the APs at the June 29<sup>th</sup> council meeting.

Program managers have reviewed and updated their draft APs that were submitted in October, 2015 for final approval by the council. Staff has attached a spreadsheet highlighting significant changes from the October 2015 draft APs.

All managers receiving money in ML 2016 appropriation are up to date with status updates and final reports. Final Reports for ML 2011 are due November 1, 2016. Staff will report back at the November 14<sup>th</sup> meeting with another update.

Thanks to Molly for sending the first response. We are short staffed at the moment and there has been a strong need to be at the Knowlton Creek Stream Restoration Project, so I was not able to provide my input. Molly's information is correct, but I will add a bit of further clarification. At the time we wrote the draft Accomplishments Plan, we were in a discussion with MPCA, USEPA and USACE about how we were going to apply funding to complete projects. The MPCA had expressed a desire to transfer OHF funds to the USACE to complete work at specific sites in the Area of Concern (Grassy, Kingsbury, 21<sup>st</sup>, and 40<sup>th</sup>). We (MNDNR) determined that we should not directly appropriate funds to the USACE based on our experience on the Mississippi. The proposed strategy was for MNDNR to complete the Grassy and Kingsbury projects with OHF and Superfund NRDA settlement funds, with design support from USACE, and MPCA/USACE would complete 21<sup>st</sup> and 40<sup>th</sup>. We would use federal funds expended at 21<sup>st</sup> and 40<sup>th</sup> as match/leverage to OHF funds applied to Grassy and Kingsbury. Therefore, we claimed the acreage of the 21<sup>st</sup> and 40<sup>th</sup> and the federal funds applied to them. Based on further discussion partners, we changed our strategy, which was after the AP was submitted. We are now operating under a tentative agreement with USEPA and MPCA that approximately \$3 million in federal funds will be applied to Grassy Point and the Kingsbury Project will be heavily supported by the Superfund Natural Resource Damage Assessment settlement. We did not claim the NRDA in ML2016, because it is not quite final. We will be applying that to the ML2017 AP, if we are fortunate enough to be allocated funding.

The general guidance given to us recently by St. Paul was to only claim match that has a very high probability of being received. If we had received that level of guidance last fall, we may not have claimed the \$10 million and the acreage of the matched projects.

It may make sense for Molly and I to come down when you have the non-consent hearings to describe this relatively complicated situation to the Council. On a more positive note, this situation should not repeat itself on a potential ML2017 AP. Hopefully this does not jade the perception of the St. Louis River Restoration Initiative in the eyes of the council.

Hi Sandy:

This is to follow-up on the voice mail I left you. I am answering on behalf of John, who is in the field at Knowlton Creek most of today.

In May 2015, the DNR St. Louis River Team requested \$10 million from USEPA for GLRI funds for the work outlined in the original 2016 proposal. At that point, we anticipated matching those funds with other projects in the estuary led by MPCA (21st Ave W and 40th Ave W). That's why we used that number and acreage in the 2016 proposal.

After discussions with DNR leadership, we are refining the proposal to reflect only the work DNR is leading at Grassy Point, which is slightly more than \$3 million (the original request was \$3 million for each of the projects plus money for staff). Leadership's directive was to report DNR work directly. However, this is different than what was proposed and from the way we have presented earlier proposals.

We are more than willing to meet with you and council members in person to make sure that this change is clear to all and consistent with council's goals and vision.

I will try to call you again this afternoon, and I know John will be talking to you tomorrow.

In reviewing the AP for Council review on June 29<sup>th</sup> it was noticed that a large amount (\$10.3 million) of leverage, original to the draft accomplishment plan was not included in the final draft. In addition, the acres (outputs) were dramatically reduced as well. Can you address this? I am sure the Council will have some conern over this change. Did the federal GLRI not come through? It looks like the anticipated date of the federal funds, originally thought to be December 2015, was changed to December 2016.
