(1:13) Members report any Conflict of Interest on Today's Agenda:

Councilmember Bronson disclosed that the City of Anoka is planning on naming the Kings Island Wildlife Area (city property) after Federal Premium Amunition, his employer. The City also received a restoration grant for the area through the Conservation Partners Legacy Grant, of which the Council recommends appropriation to the grant program managed by DNR, however the Council does not make the individual awards.

(2:22) Executive Director's Report

Mr. Bill Becker discussed the grant application system, encouraged people to take a look at it, and apply early.

Because members have had time to read and review the Legislative Session Report, Mr. Becker opened the floor to questions on the Legislative Session Report. Members discussed School Trust land management issues and limitations to the open meeting law as it related to quick decisions that needed to be made during legislative session. Members continued discussion about the open meeting law challenges as it relates to council communication.

(36:20) Discussion / Action: LSOHC Travel Policy

Members discussed the policy. Rep. McNamara and Chair Hartwell summarized that any member can visit anything it is more the question of what, if anything, should be budgeted and reimbursed to members and a process in place to request for reimbursement request. Members discussed some members having more time to visit sites and that it might be inequitable that some use more of the budgeted money than others. It was decided that staff would come back to the next Council meeting with modifications including reducing the number of days to submit a travel request reduced.
