Legislative Citation and Appropriation Language:

ML 2010, Ch. 361, Art. 1, Sec. 2, Subd. 2(b) Green Corridor Legacy Program - \$1,651,000 in fiscal year 2011 is to the commissioner of natural resources for an agreement with the Redwood Area Communities Foundation to acquire and restore land for the purposes allowed under the Minnesota Constitution, article XI, section 15, in Redwood, Renville, Brown, Nicollet, Murray, Lyon, Yellow Medicine, Chippewa, and Cottonwood Counties to be added to the state outdoor recreation system as defined in Minnesota Statues, chapter 86A. A list of proposed fee title acquisitions must be provided as part of the required accomplishment plan. The commissioner of natural resources must agree in writing to each proposed acquisition. All restorations must comply with subdivision 9, paragraph (b).

Outcomes

While protecting natural resources, wildlife, and aquatic habitats this program also promotes publicly owned natural resource infrastructure (e.g. WMA, AMA, etc)which invigorates local and regional economies by providing public access to outdoor recreation systems. New and/or expanded business opportunities related to outdoor recreational tourism are likely to arise as a direct result of this appropriation and have been advanced and promoted by the Green Corridor Legacy Program.

The Green Corridor Legacy Program - Phase II appropriation protected high quality fish, game, and wildlife habitats by creating complexes or corridors of three (3) new and/or expansions of MN DNR Wildlife Management Areas (WMA) with in the Program area totaling 447.51 acres in fee title.

Specifically; the Grunflur WMA at 164.36 acres is a new WMA complex located in Cottonwood County just south of Sanborn MN has protected a wetland structure and a small remnant native prairie parcel and is in close proximity of the Cottonwood River. This tract also protects habitat for upland game and waterfowl. This new WMA now provides greater public access to regional communities like Sanborn to this new outdoor recreational system and has the potential for future development and expansion.

The Lamberton WMA addition at 89.5 acres located in Redwood County northeast of Lamberton MN provides protection to a significant riparian drainage area and expands the existing Lamberton WMA complex. This tract also protects critical wildlife and waterfowl habitats (grasslands) that are usually associated to these types of riparian areas.

The Granite Prairie WMA at 193.65 acres is a new WMA complex located in Renville County northwest of Morton MN. This WMA protects numerous exposed granite outcrops, remnant native prairie, existing and restored hardwood forested areas, several wetland/shallow lake structures, and also protects nearly 1.1 miles of aquatic habitats along the Minnesota River shoreline. Numerous species of game and non-game wildlife inhabit this WMA and also provides water and fishing access to the Minnesota River. This tract is also adjacent to a portion of the Minnesota River Valley Scenic Byway transportation system.

The Green Corridor Legacy Programs success has been demonstrated by the numerous partnerships that have been developed from a wide variety of disciplines that will assist in monitoring outcomes, provide long range management of the acquired lands, provide technical support, and ensure that program activities will continue to advance the goals, objectives, and strategies of the various state-wide conservation plans and provide public transparency and input.

Maintenance

The DNR Division of Fish & Wildlife will permanently manage these properties. Routine maintenance will be managed by area DNR staff funded by their traditional sources like the Game & Fish Fund. Due to the proximity to other DNR properties will help keep maintenance costs less than average due to shared resources. Periodic enhancements or improvements will be funded by special funding requests. The DNR requires management plans for each project which identify periodic inspections and continuing management of the property site. These management practices include such things as; prescribed fire, weed control, and invasive tree removal. Regional partners may also support these management activities/practices by applying for state funding/grants for maintenance as needed.

Initial restoration funding of a portion of the Lamberton WMA addition was transferred to the acquisition budget to help offset an acquisition funding shortfall and was approved by the LSOHC. This restoration effort will take place in the Green Corridor Legacy Program – Phase III appropriation from FY12 OHF.

Sustainability

The fee simple acquisition of these 447.51 acres will be administered by the MN DNR Division of Fish and Wildlife for management and enforcement of state laws on these acquired properties in perpetuity. This program has acquired land in fee title from willing and supportive landowners and was transferred to the appropriate state agency for long-term habitat conservation, outdoor recreational access, sustainability, and monitoring. Payment in Lieu of tax (PILT) will be established by current or traditional methods. The Program Manager and DNR have submitted an approved Initial Development Plan (IDP).


