Appropriation Language: \$2,450,000 in the second year is to the commissioner of natural resources for a contract with The Nature Conservancy in cooperation with the United States Fish and Wildlife Service to acquire land in fee or permanent conservation easements within the Northern Tallgrass Prairie Habitat Preservation Area in western Minnesota for addition to the Northern Tallgrass Prairie National Wildlife Refuge. Lands acquired with this appropriation may not be used for emergency haying and grazing in response to federal or state disaster declarations. Conservation grazing under a management plan that is already being implemented may continue. Subject to the evaluation criteria under Minnesota Rules, part 6136.0900, priority must be given to acquisition of lands that are eligible for the native prairie bank under Minnesota Statutes, section 84.96, or lands adjacent to protected native prairie. A list of proposed land acquisitions must be provided as part of the required accomplishment plan and must be consistent with the priorities in the Minnesota Prairie Conservation Plan.

Abstract:

The Nature Conservancy (TNC) and the US Fish and Wildlife Service (USFWS) will permanently protect native prairie and associated wetland complexes in western Minnesota by purchasing fee title properties and/or habitat easements.

Design and scope of work:

Only a small portion of the original tallgrass prairie remains. Native prairie has declined by 98.7% in Minnesota. Only 235,000 acres of the original tallgrass prairie in the state remain. Of these, roughly 100,000 acres lack any form of legal protection. In addition, grassland dependent bird species have shown steeper, more consistent, and geographically more widespread declines than any other group of North American birds.

The Northern Tallgrass Prairie National Wildlife Refuge was established to preserve, restore, and manage a portion of the remaining critical northern tallgrass prairie habitat and associated habitats at widespread locations throughout the western Minnesota and northwestern lowa historic range. The number of acres purchased, however, has been limited due to funding shortfalls since the establishment of this refuge. The current land acquisition budget cannot keep up with the landowner interest in this program. This funding will provide TNC the opportunity to aid the USFWS to better meet refuge goals and objectives to protect this vanishing habitat.

TNC will work closely with the USFWS to purchase approximately 740 acres of native prairie in western Minnesota. Approximately 485 acres will be fee title acquisitions and 255 acres will be protected by permanent habitat easements. Conservancy and Service staff will review potential properties within the Northern Tallgrass Prairie Habitat Preservation Area and work together to protect these tracts.

Fee title tracts will be the top priority for the funding. Funding may also be used for the purchase of habitat easements depending on landowner intent. While easement costs vary by parcel, easements purchased as part of this program generally cost 65-75% of the unrestricted fair market value.

The majority of the lands protected will consist of native prairie. Because of the nature of parcel ownership, however, some of this acreage will likely include smaller areas of converted lands needing grassland or wetland restoration. Restoration of these lands will be completed where needed.

Lands and easements purchased through this program by TNC will be transferred to the USFWS and will become units of the Northern Tallgrass Prairie National Wildlife Refuge to be owned and managed by the USFWS.

At their October 7, 2014 meeting, the Council requested The Nature Conservancy to add the following language about salary and fringe benefit reimbursement to this Accomplishment Plan:

As provided under the subdivisions titled "Payment Conditions and Capital Equipment Expenditures" (ML 2010, Ch. 361, Art. 1, Sec. 2, Subd. 10; ML 2011, First Special Session, Ch. 6, Art. 1, Sec. 2, Subd. 10; ML 2012, Ch. 264, Art. 1, Sec. 2, Subd. 8; ML 2013, Ch. 137, Art. 1, Sec. 2, Subd. 8; ML 2014, Ch. 256, Art. 1, Sec. 2, Subd. 8) The Nature Conservancy (the Conservancy) may be reimubursed for salary and fringe benefits based on a provisional fringe benefits rate consistent with OMB Circular A-122 and negotiated annually with the Conservancy's cognizant agency. Within 120 days of the end of each Nature Conservancy fiscal year, the Conservancy will provide MN DNR with the actual fringe benefits rate for the prior year and reconcile any overpayment made by the State.

Describe the relationship of the funds:

How does this program accelerate or supplement your current efforts in this area:

This project will greatly accelerate conservation activities in prairie regions of Minnesota. Since 2000, the USFWS has received \$6,320,000 in federal Land and Water Conservation Funds. Appropriations have averaged approximately \$500,000 annually with no funding available in some years. This level of funding has allowed them to purchase fee title and easement interests in smaller sized tracts of prairie during the last 12 years. The addition of Outdoor Heritage Funds will greatly increase TNC's and the USFWS's ability to protect larger tracts of native prairie throughout the 49 Minnesota counties in the Refuge.

Significant in-kind time will be spent by US Fish and Wildlife Service Real Estate, Refuge, and Field staff on this project. This appears in the Budget attachment as In-kind/Volunteer Contributions.

Outdoor Heritage Funds will be additive to TNC's budget.

How will you sustain and/or maintain this work after the Outdoor Heritage Funds are expended:

Outdoor Heritage Funds will be used to purchase the land in fee title or to purchase perpetual habitat easements. The land purchased will be transferred to the USFWS to become units of the Northern Tallgrass Prairie NWR. Long term costs for restoration, management, and wildlife and habitat monitoring will be funded through annual USFWS operations funding. Habitat easements are perpetual and managers will work with landowners to maintain and, where needed, restore the native prairie on each tract of land.

Will there be planting of corn or any crop on OHF land purchased or restored in this program - Not Listed

Will local government approval be sought prior to acquisition - No

Local government approval will not be sought on each individual tract of land. Local MN DNR and USDA offices will be contacted regarding potential fee title/easement purchases to determine if any ongoing programs will affect acquisitions. Acquisition goals have also gone through a public review process which occurred during the development of the final Environmental Impact Statement by the USFWS as required by the National Environmental Policy Act during refuge establishment.

Is the land you plan to acquire (fee title) free of any other permanent protection - Yes

Is this land open for hunting and fishing - Yes

The fee title properties will be open to hunting and other public uses including wildlife observation, interpretation, photography, and environmental education per Minnesota Statutes 2012, Section 97A.056, Subdivision 19(b). The properties where habitat easements are purchased will stay in private ownership and therefore will not be open for public use unless that landowner authorizes those uses.
