Narrative

Summary of Accomplishments

This program enhanced 10,583 and restored 198 acres for a total impact of 10,781 acres by restoring wetlands, removing invasive trees, seeding prairies, prescribed burning, and installing infrastructure for conservation grazing. These practices took place on Waterfowl Production Areas (WPA's), and Wildlife Management Areas (WMA's) in the prairie, metro and the forest/prairie transition regions of Minnesota. We exceeded our acre goals in every category, brought \$45,768.51 in match funds, and are returning \$833.50 in funds.

Process & Methods

Pheasants Forever sent a Request for Proposal (RFP) to wildlife managers within the MN DNR (managing WMA's), and USFWS (managing WPA's), giving them the opportunity to submit projects to be funded under this phase. Eligible practices included wetland restoration, invasive tree removal, upland enhancement/restoration, prescribed fire, and conservation grazing. Projects were ranked based on cost and priorities such as the impact on threatened & endangered species, project location within Conservation Plan Focus Areas, size of the complex, and potential benefit to water quality. For selected projects, PF restoration staff worked with area wildlife managers to develop restoration/enhancement plans and translate those into statements of work (SOW). The SOW was sent along with the Request for Bid to local contractors as part of the solicitation process that is laid out in PF's Procurement Policy. Once awarded, PF and agency staff monitored construction to ensure work was completed to quoted specifications, in time, and on budget.

How did the program address habitats of significant value for wildlife species of greatest conservation need, threatened or endangered species, and/or list targeted species?

Value to T&E species is one of our project ranking criteria as part of our RFP. Projects that directly benefitted T&E species were more likely to be funded. In addition, all projects were carefully planned and monitored to mitigate any negative impact to T&E or SGCN.

How did the program use science-based targeting that leveraged or expanded corridors and complexes, reduced fragmentation, or protected areas in the MN County Biological Survey.

As with T&E and SGCN, we specifically prioritized project sites in complex areas, as well as sites within the MN Prairie Conservation plan in the RFP. By targeting restoration and enhancement in ecologically strategic areas, our efforts directly reduce habitat fragmentation and expand habitat corridors.

Explain Partners, Supporters, & Opposition

This program works closely with MN DNR and USFWS managers to complete work on proposed projects on WMA's, and WPA's. Often, these projects are brought to managers attention by members of the hunting community or other non-profit conservation groups. We again partnered with the North American Wetlands Conservation Act to provide leverage and financial assistance to complete large wetland restoration projects. No significant opposition was brought to our attention as a result of these restoration and enhancement projects.

Exceptional challenges, expectations, failures, opportunities, or unique aspects of program

While working through multiple phases of this program, we start to witness true landscape level changes with regards to prairie grassland and wetland habitats. As with any program, there are always minor challenges and failures, ranging from weather delays and conflicts with contractor schedules, to wetland restorations being infeasible due to neighbor disputes. New to this phase we've also included navigating restrictions due to COVID-19 to the list of challenges. Diligence and the outstanding relationship PF has with its agency partners led us to overcome these obstacles and impact over 10,782 acres, which, compared to other states is a unique opportunity to seize.

What other dedicated funds may collaborate with or contribute to this program?

What is the plan to sustain and/or maintain this work after the Outdoor Heritage Funds are expended?

Most of the work completed in this program takes lands that are of lower quality habitat for wildlife and improves them. One example of this is removing invasive trees from grassland habitat. This work will generally allow the unit to be managed more effectively by allowing the manager to focus on grassland management instead of invasive species management. While it's difficult for a third party like Pheasants Forever to provide an analysis of future costs on existing public land, work done under this proposal will facilitate future management activities.

How did you determine which portions of the Direct Support Services of your shared support services is direct to this program?

PF utilizes the Total Modified Direct Cost method. This methodology is annually approved by the U.S. Department of Interior's National Business Center as the basis for the organization's Indirect Cost Rate agreement. PF's allowable direct support services cost is 4.12%. In this proposal, PF has discounted its rate to 1.5% of the sum of personnel, contracts, and travel. We are donating the difference-in-kind.

Explain any budget challenges or successes:

PF was able to bring an additional \$45,768.51 in federal match funds via the North American Wetland Conservation Act, allowing us to complete numerous large wetland restoration projects.

• Improved condition of habitat on public lands ~ This program directly addressed the prairie region outcome to improve by condition of habitat on public lands as all practices did exactly that. We enhanced 10,336 and restored 185 acres for a total of 10,521 acres in this region.


