#### **Abstract**

The Minnesota's Heritage Forest – Transition to Public Ownership Program is focused on the protection of forest lands in northern Minnesota by purchasing land from The Conservation Fund (TCF) for permanent conservation, management and protection by MN DNR and northern MN Counties. In 2020 TCF purchased more than 72,000 acres of forest land Minnesota from the PotlatchDeltic Corp., securing these lands to provide time for conservation partners to permanently conserve these forest lands. DNR seeks to purchase 10,688 acres in fee and Northern Waters Land Trust (NWLT) 7,680 acres to transfer to Counties.

#### **Design and Scope of Work**

TCF indicated that their purchase from the PotlatchDeltic Corp. is to provide time for permanent conservation with partners. DNR's goal is to protect water quality and wildlife habitat while also preserving working forestlands, safeguarding jobs, contributing to local economies, increasing climate resiliency, and public access. DNR's Heritage Forest Project focuses on forest and habitat protection located in the northern forest region. Working with partners, DNR has implemented a four-phase project plan: Phase 1 (2021-2022) – interdisciplinary team applies DNR's Strategic Land Asset Management metrics to all TCF-owned parcels; engagement with Tribes, Counties and conservation partners. Phase 2 (2022) - DNR staff worked directly with county leaders to apply local expertise & coordination. Phase 3 (2022-2023) – refined priority parcel lists; seek county and Tribal support; develop acquisition strategy including funding proposals; work with NWLT to coordinate acquisitions with Counties and Tribes; complete appraisal for DNR proposed parcels. Phase 4 (2024-2028) – if funded, acquire parcels. Many of the Heritage Forest lands are near DNR-managed lands, including existing State Forests. Some lands are suitable for DNR acquisition/management for various conservation purposes (State Forests, WMAs, & SNAs): working forests, protection of important, rare, or diminishing habitats and native plant communities and public access. DNR is working with Counties who have identified parcels for ownership and parcel lists are being refined with NWLT coordination. This project systematically evaluates, prioritizes, and (if approved) will acquire parcels for DNR management with significant local and Tribal input. NWLT is currently using OHF grants for wildlife habitat and tullibee watershed protection and has already completed "bargain sale" transactions, purchasing and transferring more than 1,600 acres from TCF to Hubbard County and DNR for permanent protection. With completion of DNR's Phase I, NWLT has been coordinating with Counties and Tribes to identify parcels for acquisition. Lands of interest expand/connect core habitat, address access, support local timber/recreation based economies, protect waters, support climate adaptations/resiliency, and protect critical habitat. Counties selected parcels for strategic reasons including: (1) consolidation/adjacency to County lands (2) securing/improving public access (3) securing/improving forest management access. NWLT will acquire parcels prioritized by Counties, then transfer parcels to each county for permanent ownership.

Parcels strategically identified for acquisition are large forest blocks threatened by conversion and/or parcelization. Nearly 7.5 million acres (44%) of MN's forests are privately-owned and at risk of fragmentation/conversion. MN has had some of the highest conversion rates in the U.S., with the highest in North Central MN. Protection work achieves multiple benefits by conserving critical habitat, maintaining forested land cover essential for high water quality/quantity and sustaining the forested landscape critical for local timber/tourism jobs. This work is critical to conserving wildlife that require large intact forests and provides permanent protection for wildlife that inhabit these landscapes. By protecting forests, we protect drinking water, recharge aquifers, reduce nutrients/sediments to lakes and streams, sustain fisheries and mitigate climate change. Protection of forested land is critical for local economies.

# Explain how the proposal addresses habitat protection, restoration, and/or enhancement for fish, game & wildlife, including threatened or endangered species conservation

The predominant threat for wildlife Species in Greatest Conservation Need (SGCN) and protected species is habitat degradation, loss and fragmentation. Maintaining intact and healthy forest habitat, especially large contiguous tracts, reduces stressors on these populations. Permanently protecting parcels in this proposal as public land maintains core forested areas and connectivity and increases the resilience of these areas to a changing climate, invasive species and other habitat threats. The proposed project uses science-based targeting methods to leverage and expand existing habitat corridors and complexes, reduce fragmentation and protect areas identified as priorities in several plans and conservation initiatives, including the MN County Biological Survey. DNR formed a statewide team with land acquisition/management experts from all DNR Divisions to apply and assess the DNR's GIS-based Strategic Land Asset Management metrics to all TCF-owned parcels to expand protection of large habitat blocks and corridors. The priority tracts of forest land and habitat targeted for protection have some, if not all, of the following traits: are currently unprotected inholdings; large tracts identified by the MN County Biological Survey (including sites of high quality biodiversity significance); corridors and habitat identified by the State Wildlife Action Plan as significant; presence of rare species and Species in Conservation Need or the habitat that support those species; located in a strategic habitat complex and adjacent to other protected land so that complexes can be protected and management improved. In addition, we consult with local and regional watershed/landscape planning efforts: TNC's Multiple Benefit Analysis and Resilient Lands Mapping Tool, DNR's Forest Action Plan, PCA's watershed plans, One Watershed One Plans, MFRC's Regional Landscape Plans, SNA Strategic Land Protection Plan, and Landscape Stewardship Plans.

Targeted habitats of our proposal include: upland forests, forested wetlands, non-forested wetlands and stream and lake shoreline. Protection of these lands provides critical habitat for key forest game species including upland birds, white-tail deer, moose, black bear, fisher, pine marten and waterfowl as well as songbird and other non-game wildlife species. In total, this proposal supports habitat protection with significant value for nearly 200 Species in Greatest Conservation Need.

#### What are the elements of this proposal that are critical from a timing perspective?

TCF purchased lands in 2020 providing 10 yrs (2030) for permanent conservation; working with Tribes and public agencies first then shifting to private buyers. DNR will begin the fair-market appraisal summer 2023 (bonding funds), then complete one bulk purchase transaction. NWLT will begin their appraisal when funds are available. Both will be ready to utilize OHF when funds are available summer 2024 to complete acquisitions. DNR/NWLT will reduce the time TCF holds lands to acquire at the lowest cost and maximize use of State funds. NWLT is currently using OHF grants to acquire and convey TCF lands for habitat/watershed protection through partnering with Crow Wing SWCD in 2021 & using NWLT's existing OHF. By May 2023 NWLT will have assisted/purchased 2,000 ac. from TCF in 4 separate transactions, all below fair market value. These "bargain sales" purchase price range from 25%-43% of appraised values.

# Describe how the proposal expands habitat corridors or complexes and/or addresses habitat fragmentation:

A serious and significant threat to MN's northern forests is conversion for other uses: the MN Forest Resources Council has identified parcelization as "the single most important policy issue affecting the economic and ecological health of the state's forests". The OHF: 25 Year Framework cites that "forest land has been converted to other uses…at a rate of 3,600 acres per year". The MN Forest Vision recommends that the "forest land base is enlarged and protected through permanent conservation easements and fee title acquisition" & "contiguous forest complexes should be protected and enlarged…and there should be focus to protect areas with high game populations and high levels of biodiversity". The State Wildlife Action Plan reports that "activities that fragment or

degrade habitats can independently or in conjunction with invasive species reduce biological diversity" & "Habitat degradation, loss, and fragmentation are the predominant stressors impacting SGCN populations. Habitats with higher biological diversity and that are less fragmented are expected to have greater climate change resiliency than are systems with lower biological diversity and greater fragmentation." Protection of proposed lands reduces habitat loss/fragmentation & maintains forest habitat complexes. This project would expand permanently protected habitat complexes & avoid habitat conversion/development/fragmentation/degradation. The MN Heritage Forest project provides enhanced connectivity between conservation lands. A key strategy for climate change mitigation is providing corridors/connectivity between different biomes/microclimates allowing species to migrate to find suitable habitats that replace former habitats lost as the climate changes. However, many species may not be able to migrate over developed/cultivated land; providing habitat corridors for species movement benefits their ability to relocate. The MN Statewide Conservation & Preservation Plan says "forest fragmentation reduces resiliency and habitat quality for wildlife including species such as bears and wolves which need large tracts of undeveloped land". The Plan identifies the critical need "to increase forest ecosystem resilience through maintenance of large blocks of forested land and forest resource health. This requires protection of forestlands against conversion to other uses, and conservation of working forestland resources through sustainable management."

Explain how this proposal will uniquely address habitat resilience to climate change and its anticipated effects on game, fish & wildlife species utilizing the protected or restored/enhanced habitat this proposal targets.

This project enhances habitat resiliency to climate change by incorporating resources & tools developed by the State, land conservation organizations, forest ecologists, aquatic biologists, environmental analysts, climate experts, & engaged community members. By prioritizing areas for conservation, identifying vulnerable species & incorporating best practices, this proposal protects & enhances habitats crucial to the resilience of game, fish, & wildlife species. The MN State Wildlife Action Plan uses SGCN population viability & richness, spatially prioritized MN Biological Survey Sites of Biodiversity Significance, Lakes of Biological Significance & Stream Indices of Biological Integrity to score areas. The project includes areas that score highly, indicating an elevated need for habitat protection. The permanent protection of forest land will contribute to the protection of habitat by expanding protected core areas & corridors of forested habitat directly benefiting the 198 SGCN in the project area & maintaining essential migratory habitat for species dependent on intact high biodiversity.

Describe how this project/program will produce and demonstrate a significant and permanent conservation legacy and/or outcomes for fish, game, and wildlife, and if not permanent outcomes, why it is important to undertake at this time:

We will acquire significant strategic priority forestland & habitat, permanently protecting lands through ownership & management by DNR & several northern Counties. This may be the last opportunity to conserve and protect

forest land & habitat at such a large scale in MN led by a coordinated effort of DNR, Counties & TCF as the NGO partner. Land protection at this large scale has a tremendous impact & addresses goals & priorities in several management plans & conservation initiatives, as described in this proposal.

Lands acquired by DNR will become part of three management systems: State Forest, Wildlife Management Area (WMA), & Scientific and Natural Area (SNA). Fee acquisition increases management efficiency through improved access for habitat management & consolidation of existing State lands. Funding for management of State Forests comes from the Forest Management Investment Account and General Fund. Funding for management of SNAs comes from OHF, ENRTF, RIM/critical habitat license plates, and infrequently from bonding, or other appropriations. SNA does not have a larger internal revenue-generating source such as park admission fees or hunting licenses. Funding for management of WMAs comes from a variety of sources.

Lands acquired for Counties will become part of County owned & managed forest land portfolios, increasing management efficiency, public access, habitat consolidation & connectivity. Funding for management of these lands comes from various County sources.

This project cannot be scaled without significantly increasing costs and jeopardizing land availability. These acquisitions are "shovel ready", there is a willing seller, & there will be significant savings if the lands are purchased as soon as possible.

#### **Outcomes**

#### Programs in the northern forest region:

• Forestlands are protected from development and fragmentation ~ This project will permanently protect 18,368 acres of northern forest and riparian areas including wetlands, streams, shoreland, small lakes and ponds. All northern forest parcels included in this proposal are at high risk of fragmentation and conversion. Forest protection activities will be assessed, management planning required/documented and properties monitored. Forest composition will be inventoried; wildlife populations will be monitored.

Funding for management of SNAs comes from OHF, ENRTF, RIM/critical habitat license plates, and infrequently from bonding, or other appropriations. Funding for management of WMAs comes from a variety of sources.

Lands acquired by Counties will become part of their respectively owned and managed forest land portfolios, increasing management efficiency and public access. Funding for management of these lands comes from various County-identified sources.

# Provide an assessment of how your program may celebrate cultural diversity or reach diverse communities in Minnesota, including reaching low- and moderate-income households:

This project will benefit BIPOC communities throughout the entire state of Minnesota by permanently protecting ecosystem services that provide clean drinking water, productive habitat, clean air, climate change mitigation, sedimentation/erosion control, and public recreational opportunities. Specific project scoring and implementation efforts benefit BIPOC and diverse communities through recreational opportunities that are close-to-home, culturally responsive and accessible to Minnesotans of all abilities.

The Environmental Protection Agency has developed an environmental justice mapping and screening tool. This tool indicates several of the proposed parcels fall within areas identified as environmental justice areas of concern. Demographic indicators used are: percent low-income, percent people of color, less than high school education, linguistic isolation, age under 5 and over 64. Protecting these lands mitigates some of the environmental justice concerns for at-risk populations.

NWLT and DNR have prioritized building relations with the Sovereign Tribal Nations in Northern Minnesota. Establishing strong relationships and partnerships takes time and commitment. NWLT and DNR directly included Minnesota's Sovereign Tribal Nations in the parcel prioritization process for this proposal. Project outreach and engagement with Minnesota's Sovereign Tribal Nations will continue to be a priority as this project continues. The DNR has diversity, equity and inclusion strategies that benefit all Outdoor Heritage Fund projects including: public engagement that seeks out BIPOC voices and involves diverse communities, outreach and marketing of projects has this focus as well; and partnerships are at the center of all projects. NWLT unites people from all backgrounds and cultures through water stewardship. NWLT does this by cultivating a conservation ethic and directly engaging all people in practical solutions through volunteer opportunities, informative workshops, and land conservation.

#### Describe the types of trails or roads and the allowable uses:

Forest access roads and trails have been developed by previous industrial forest landowners for forest management practices. Historically these roads and trails have been open to the public. These roads and trails will be maintained to provide ongoing access for forestry, fisheries and wildlife management activities and public use on the properties. There are a few Counties where there are established snowmobile trails going through NWLT priority acquisition parcels or are bordering these parcels. These snowmobile trails have been identified on the NWLT-County maps - see attached NWLT-County maps.

# Will the trails or roads remain and uses continue to be allowed after OHF acquisition? Yes

#### How will maintenance and monitoring be accomplished?

Maintenance of access roads and trails will be the responsibility of the DNR on parcels proposed for DNR acquisition. Individual Counties will be responsible for maintenance of access roads on

parcels proposed for acquisition by Counties. DNR monitoring of roads and trails will be conducted on properties acquired by the DNR; the DNR has a monitoring and reporting plan in place that involves the Divisions of Forestry, Parks and Trails and Enforcement. This includes annual spring (and other wet season) closures, reporting issues and enforcement actions when necessary. Counties will be responsible for monitoring and enforcement issues on properties owned by Counties.

### Will new trails or roads be developed or improved as a result of the OHF acquisition?

Yes

#### Describe the types of trails or roads and the allowable uses:

New trails or roads will be developed only if necessary for forest/wildlife management activities. Any new road or trail will be developed and managed consistent with the public entity's land management practices and policies.

No new trails or roads are planned on State property. Scientific and Natural Areas (SNA) and Wildlife Management Areas (WMA) do not include motorized vehicle use unless allowed by pre-existing access easement. SNA and WMA will likely honor existing access easements, but new areas of motorized use are incompatible with SNA and WMA public uses.

#### How will maintenance and monitoring be accomplished?

Maintenance of access roads and trails will be the responsibility of the DNR on parcels proposed for DNR acquisition. Individual Counties will be responsible for maintenance of access roads on parcels proposed for acquisition by Counties. DNR monitoring of roads and trails will be conducted on properties acquired by the DNR; the DNR has a monitoring and reporting plan in place that involves the Divisions of Forestry, Parks and Trails and Enforcement. This includes annual spring (and other wet season) closures, reporting issues and enforcement actions when necessary. Counties will be responsible for monitoring and enforcement issues on properties owned by Counties.



The proposed project uses several science-based targeting methods identified in several plans/conservation initiatives to identify, prioritize, and select parcels proposed for acquisition identified in several plans and conservation initiatives. DNR formed a statewide interdisciplinary team with land acquisition and management experts from all DNR Divisions (Ecological and Water Resources, Fish and Wildlife, Forestry, Lands and Minerals, Parks and Trails) to apply and assess the DNR's GIS-based Strategic Land Asset Management metrics to all TCFowned parcels to expand protection of large habitat blocks and corridors. The priority tracts of forest land and habitat targeted for protection with this program have some, if not all, of the following traits: are currently unprotected inholdings; large tracts that have been identified by the Minnesota County Biological Survey (including identified sites of high quality biodiversity significance); corridors and habitat identified by the State Wildlife Action Plan as significant; presence of rare species and Species in Conservation Need or the habitat that support those species; located in a strategic habitat complex and are adjacent to other protected land so that complexes can be protected and management improved. In addition DNR consulted with local and regional watershed and landscape planning efforts such as The Nature Conservancy's Multiple Benefit Analysis and Resilient Lands Mapping Tool, DNR's Forest Action Plan and Assessment of Need, PCA's watershed planning efforts, BWSR's and local SWCD's One Watershed One Plan efforts, the MFRC's Regional Landscape Plans, and the DNR/BWSR Landscape Stewardship Plans.

In 2020 The Conservation Fund (TCF) purchased more than 72,000 acres of forest land in northern Minnesota from the PotlatchDeltic Corporation, securing these lands to provide time for conservation partners to permanently conserve these forest lands.


### JOINT PROPOSAL

NWLT and MN DNR are working together to ensure this forested land remains forested. NWLT will acquire 7,680 acres and transfer to Counties for permanent management. MN DNR will acquire 10,688 acres and manage as State Forest, WMA, and SNA land.

# **NWLT & COUNTIES**

NWLT has coordinated with 14 Counties and four Tribes to identify parcels of interest. **Nine Counties are collaborating** with NWLT to receive land as a part of this proposal. The Counties strategically selected parcels primarily to:

- 1. Consolidate, connect, and expand existing County lands
- 2. Secure and improve public access
- 3. Secure and improve forest management access

# **BARGAIN SALE**

NWLT has successfully used existing OHF funding to purchase 1,600 acres of TCF/MN Heritage Forest land and transfer to Hubbard County and MN DNR for permanent protection. All three transactions have been bargain sales, resulting in purchase prices 25%-43% below appraised values. TCF has confirmed bargain sale prices for these proposed acquisitions.

**BACKGROUND** — In 2020, The Conservation Fund (TCF) purchased 72,000 acres of working forest lands from Potlatch Deltic which are scattered across 14 counties in northern and north-central Minnesota. DNR formed an interdisciplinary project team which analyzed the parcels, and through consultation with Tribes, Counties and conservation entities, strategically identified 10,688 acres of high-priority conservation lands proposed for state acquisition. DNR and Northern Waters Land Trust (NWLT) are working together to ensure this land is protected and managed through public ownership...keeping forested land forested. DNR will acquire 10,688 acres and NWLT will acquire 7,680 acres and transfer to nine Counties.

BENEFITS TO MINNESOTANS — Minnesota's forests provide wildlife habitat, public recreation spaces, timber and wood fiber, as well as watershed health, carbon sequestration and storage and timber and recreation-based jobs. The Heritage Forest acquisition proposal is a rare opportunity to conserve the best of these lands for a wide variety of public benefits for the future—in a cost-effective, efficient way.

#### A ONE PROJECT APPROACH: ONE APPRAISAL—ONE PURCHASE

To minimize transaction costs and ensure the lands are evaluated with the same set of decision-making metrics, DNR seeks to acquire the priority lands as a single purchase.

The DNR must use taxpayer dollars efficiently and combining all of the parcels into a single appraisal and single purchase provides the most efficiency and lowest cost.

#### IS THIS PROJECT SCALABLE?

This project cannot be scaled without significantly increasing and Acreages: costs and jeopardizing availability of the land for purchase. The acquisitions are "shovel ready": there is a willing seller, tremendous public support and cooperation, and there will be significant savings if the lands are purchased as soon as possible. Because the DNR's approach is the "one appraisal one purchase transaction" (see above), the DNR acquisition cannot be scaled over multiple transactions over time. TCF costs to hold lands include the original purchase price plus monthly costs (taxes, interest, administration) minus income (leases and timber sales). Adding time to the purchase reduces the discount that TCF can pass on to the purchaser, meaning less land will be able to be purchased for public ownership and protection over time. DNR will begin their appraisal summer 2023.

Most of the confirmed leverage (\$3M) is a mix of generated and existing RIM credits; and ENRTF (\$1.2M) for purchase of SNA acres. The remaining (\$163,000) is from bonding, general fund and federal sources.

In addition to leverage, we anticipate a large savings in *bargain sales* of the lands (for both DNR and NWLT), which we estimate will result in purchase prices well below appraised values (25%-43%). *TCF* has confirmed bargain sale prices for the proposed acquisitions.
