Lessard-Sams Outdoor Heritage Council Recommendations — FY2027

LSOHC Recommendations Highlights

In the eighteenth year of Outdoor Heritage Funding (OHF), the Lessard-Sams Outdoor Heritage Council is recommending a total of 53 programs be funded by the MN Legislature for a total of \$188,922,000.

- 68,754 acres of wildlife habitat throughout Minnesota is estimated to be restored, enhanced, and/or protected.
- 40 miles of shoreline will be restored, enhanced and/or protected.
- An additional \$15,129,000 in federal, local government, and private conservation funding is expected to be leveraged.
- 29 individual organizations are recommended for funding: 2 state agencies, 11 local units of government, 1 university, and 15 nonprofit organizations.
- Continued investment in robust, ongoing programs constitutes 75% of the recommended funding.
- Activities include: native prairie protection, wetland restoration, trout stream enhancement, public wildlife land enhancements, shallow lake enhancement, forest fragmentation prevention, strategic land acquisition in fee and conservation easement, invasive species removal, restoring fish passage, and pollinator habitat.



Prescribed Fire / Invasive Cattail Removal
Voyageurs National Park utilized Outdoor Heritage Funding to treat and remove large areas of invasive non-native cattails within the Park. Invasive cattails have become an increasing threat within the Park and throughout the entire state of Minnesota.



Rock Arch Rapids - The failing Pelican Rapids Dam in Pelican Rapids, MN was replaced with a rock arch rapids that improves aquatic habitat, allows fish passage, and enhances public safety. The Lessard-Sams Council toured the site in June 2025.

Constitutional Amendment - Article XI—Sec. 15.


...33 percent of the receipts shall be deposited in the outdoor heritage fund and may be spent only to restore, protect, and enhance wetlands, prairies, forests, and habitat for fish, game, and wildlife;...

...The dedicated money under this section must supplement traditional sources of funding for these purposes and may not be used as a substitute. Land acquired by fee with money deposited in the outdoor heritage fund under this section must be open to the public taking of fish and game during the open season unless otherwise provided by law...




Output by FUNDING
