

Lessard-Sams Outdoor Heritage Council Conflict of Interest Disclosure Form

Council members are required to complete this form to disclose any actual, potential, or perceived conflicts of interest that exist. It is the Council member's obligation to be familiar with the Conflict of Interest Policy for the Lessard-Sams Outdoor Heritage Council (LSOHC) and to disclose any conflicts of interest. The Council member is not required to explain the reason for a conflict of interest. This information is considered public data under [Minn. Stat. § 13.599](#). This completed form will be posted to the LSOHC website. **A disclosure does not automatically result in the Council member being removed from the Council recommendation process.**

Please read the conflict of interest guidelines below and mark the boxes pertaining to you and your status as a Council member recommending requests for funding from the Outdoor Heritage Fund.

This guide synthesizes applicable requirements from [Minn. Stat. § 97A.056, subd. 4](#), [Council Operating Procedures](#), Council conflict of interest policies, and [Office of Grants Management Policy 08-01](#). A conflict of interest may be present even if no unethical, improper, or illegal act results from it. A conflict of interest occurs when the Council member or others affiliated with the Council believes any one of the following conditions exist:

A **conflict of interest** occurs when a Council member has actual or apparent duty or loyalty to another organization and the competing duties or loyalties may result in actions which are adverse to one or both parties. Circumstances that require disclosure include:

- a) Receipt of personal financial benefit from a proposing organization or request for funding being reviewed.
- b) Serving as an employee or governing board member of a proposing organization whose request for funding is being reviewed.
- c) Having a family relationship with someone requesting funds or a staff or board member of a requesting organization.

Organizational Conflict of Interest

An **organizational conflict of interest** occurs when a Council member has an affiliation with an organization that is subject to Council activities, which presents the appearance or reality of a conflict between organizational interests and Council member duties. A conflict does not exist if the member's only affiliation with an organization is being a member of the organization. An organizational conflict of interest may be an **actual** or **possible perceived conflict of interest**.

Actual Conflict of Interest

An **actual conflict of interest** occurs when a Council member's decision or action would compromise a duty to a party without taking immediate appropriate action to eliminate the conflict. An **actual conflict of interest** must be declared if:

- a) A council member uses their status or position to obtain special advantage, benefit, or access to the person making a request for funding or the requesting entity's time, services, facilities, equipment, supplies, badge, uniform, prestige, or influence.

- b) The Council member, an organization they are involved with, or an immediate family member stands to receive a direct or indirect financial benefit, money, equity, or anything of value from a request for funding or a funded project.
- c) A council member is an employee or board member of an organization requesting funding or is a family member of anyone employed by or a board member of the applying organization.

Potential or Perceived Conflict of Interest

A **potential or perceived conflict of interest** occurs when a Council member has apparent duty or loyalty to more than one organization and the competing duties or loyalties may result in actions which are adverse to one or both parties. Disclosure is required for any situation in which a member's judgment, actions or non-action could be interpreted to be influenced by something that would benefit them directly or through indirect gain to an immediate family member, business, or organization with which they are involved.

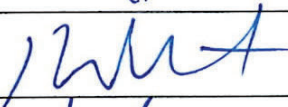
