RE: Information on Status Updates due on August 14, 2020

Status Updates were due for all programs on August 14, 2020. Attached are two lists that may be helpful; 1) by approp year with percentages spent to date, 2) by phased program showing final report and update figures.

The programs that were near completion and a final report expected were given the option of completing a status update or not. Generally, final reports for ML 2015 programs are due November 1.

Although the percentage of funds spent-to-date can provide members with a basic idea of program progress, recognize that it doesn't tell the entire story. Each is unique with their own circumstances and details. Some managers reported a high level of accomplishments and low spending. This is the case where some managers included encumbrances and others did not. Overall, staff reviewed the updates to make sure that programs appeared to be making progress for timely completion and accomplishment of the stated outputs.

As a reminder, acquisition programs have 3 years to acquire land, while Restoration/Enhancement programs have 5 years to complete work or up to 5 years after the acquisition, if applicable.

#### **DNR IDP Money**

Non-state agencies transfer money over to the DNR for IDP (Initial Development Plan). These monies are estimates on various tasks (parking lots, signage, R/E work, etc) that need to be completed relating the development of the parcels transferred to DNR for inclusion in the public land system. In several cases, as indicated by "IDP money left" this is the second, third, and sometimes forth status update where the last bit of the appropriation (IDP) needs to be spent. This primarily affects the closing of ML 14, ML 15 and a few ML 16 appropriations. There are several concerns over the slowness in which DNR is accomplishing this task:

- Managers who have completed the appropriation years earlier are continuing to report and follow up on the IDP progress therefore adding to the administration for work not in their control.
- 2) The inability to officially close out the appropriation with MMB, therefore prevents remaining money from these programs, although usually small, to be re-deposited into the OHF for future recommendations.
- 3) Without an official final report in the system, those accomplishments are not captured via system reports when staff has to produce information for reporters and legislative presentation.

Staff has discussed this with DNR. A IDP Coordinator position was funded in the ML 2020 DNR WMA program. This position will help to expedite spending of these expenses. We anticipate the closing of those programs IDP monies so that close out can happened prior to the next status update in February 2021.

### **COVID-19 Extensions**

While the extension of time in the 2020 Appropriations bill (details in the above table) bill helped extend time beyond the pending deadlines in the following ways:

ML 15 – Restoration and Enhancement programs received an extra year. This was helpful for crews that were pulled off site during the state shut down and were later allowed to resume activities within the extended time for final completion.

ML 16 – Acquisition programs received an extra year to close on parcels that were under commitment. This was helpful to assist in the coordination of title work, surveys, and closings that were scheduled and delayed.

ML 17 – Acquisition programs received an additional year to find parcels, but no change in the closing period. This assisted with negotiations that were delayed with landowners due to due to social distancing, and delayed completion of survey and legal work associated with negotiations.

In reading the updates, it appears that ML 18 programs may benefit from additional time as well. Since these programs started July 1, 2018 and many of the activities were interrupted or stopped for a period of time in the middle of the programs, therefore they would not benefit from the entire time of the appropriation availability.

# Wild Rice Watershed Program

The ML 2015 program received a Legislative Extension in ML 18 law until 2021. This extension was to allow additional time to work out details regarding a MOA with BWSR for RIM easements.

Staff will be scheduling a conference call with the manager to get an update on progress and plan for completion. Overall the program is slow to spend and appears that no money has been spent to date in any of the approp years.
