4. Discussion: OHF Proposal Criteria/Scoring: Chair Hartwell noted that Council staff had taken the subcommittee's recommended proposal criteria/scoring changes from the previous meeting and had integrated the changes into several draft documents that had been provided to subcommittee members prior to the meeting. Committee discussion followed.

Staff was directed to:

- Remove the words "targeted species" from hearing criteria #3.
- Reword hearing criteria #12 to read, "Proposal is reasonable in its size (full score), or inflated to compensate for reduced funding (low score)."
- Make the full value of each hearing criteria question 10 points.
- Keep staff suggested wording for question related to statewide conservation plans, with the addition of a reference to 97A.056.
- Shift all questions related to matching/leverage funds to the same place in the proposal.
- Maintain the question regarding neonicotinoid use, but work on creating a better/clean version.
- Create a data table for phased programs showing total monies previously allocated, how much of that total remains unspent to date, the percentage of monies spent to date, total amount of leverage promised, and percentage of promised leverage realized to date.
- Create better contrast on parcel map, including ensuring map is accessible to those who are colorblind and/or have other vision accessibility needs.

Action: Councilmember Kristin Eggerling made a motion that the revised proposal and hearing criteria drafted by the subcommittee be presented to the full Council for approval at the January 27, 2023 meeting.
