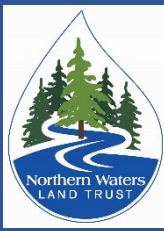

Pancake Lake, Cass County

Land Protected: 222 acres

Shoreline Protected: 10,607 feet

Through a conservation easement, Pancake Lake is now surrounded by 222 acres of undeveloped and permanently protected hardwood forest and wetlands, including forested peatlands, bog, and wet meadows. This natural landscape will help preserve the water quality and aquatic habitat of Pancake Lake. In addition, the land is on a portion of Boy River, which connects seven deep, tullibee refuge cold water lakes.

Roosevelt Lake Aquatic Management Area (AMA), Cass and Crow Wing Counties

Land Protected: 111 acres

Shoreline Protected: 5,900 feet

Roosevelt Lake AMA on Woods Bay in Cass and Crow Wing Counties was established in 2016, made possible with fee title acquisition Phase 1 funding of this program. The AMA was further expanded in March 2023 with a land donation, supported with funding from Phase 4. The AMA now totals 111 acres of land and safeguards 5,900 feet of “sensitive shoreland,” as designated by the MN Department of Natural Resources.
