Chair David Hartwell discussed the letter that the Council received regarding unauthorized use of Neonicotinoid products on LSOHC funded lands, and how to ensure that verification is done on the use of Neonicotinoid products going forward. Councilmember Swenson raised a potential concern that a small number of organizations are involved on a large percentage of project proposals.
